Key Insights

The Meredith Poll conducted a survey of North Carolina registered voters. The online sample--from Qualtrics--used a quota based on the U.S. Census Bureau's estimates of the North Carolina population and current data on N.C. voter registrations and turnout of voters. After the survey was completed, we **weighted** the survey for **gender**, **party affiliation**, **geographic location**, **race and ethnicity**, and **education** so that our sample most closely resembles North Carolina.

The sample had 759 respondents, giving us a confidence interval of +/-3.5%. The survey was in the field April 2-8, 2025.

Satisfaction with the Direction of the Country and State

Satisfaction with the Direction of the Country

North Carolinians, despite a change in presidential administration, continue to be dissatisfied with the direction of the country. Slightly less than one-third of the respondents (32%) indicated they were satisfied with the way things are going in the country, while 60 percent indicated they were dissatisfied with the direction of the country.

The dissatisfaction with the direction was almost universal across demographic groups. Democrats and Republicans had a majority of their respondents dissatisfied with the direction of the country. Only those over 80 years of age were satisfied with the direction of the country.

"It is unusual for all partisan respondents to be dissatisfied with the direction of the country," said Meredith Poll Director David McLennan. "Typically, respondents of the party that controls the White House are more positive about the direction of the country. The fact that a majority of Republicans are dissatisfied with the direction of the country, particularly after recently winning the presidential election, bodes poorly for Donald Trump's approval and how the Republicans will fare in the 2026 midterm elections."

Satisfaction with the Direction of the State

Our respondents were more satisfied with the direction of the state than of the nation, but not optimistic. They were equally divided (42%-42%) between those satisfied with the direction of the state and those dissatisfied with it. There were differences in how different groups viewed the direction of the state. A plurality of Republicans saw the state moving in a positive direction, yet a plurality of Democrats and Unaffiliated respondents perceived that things were not going well in the state. Those in urban areas were more dissatisfied than those living in rural areas of the state, while those who were most educated were more satisfied than not.

"People are generally more satisfied with how things are going in North Carolina than in the nation. That is not unusual," said David McLennan. "However, the fact that less than a majority of North Carolinians are satisfied with the direction of the state is a sign that people are generally unhappy with conditions."

Perceptions of the Economy and People's Personal Financial Situations U.S. Economy

North Carolinians are very sour on the U.S. economy at the moment, with two-thirds reporting that the economy is somewhat or very weak. Only 31 percent feel the economy is strong. People are somewhat more optimistic about the economy a year from now with 43 percent indicating it will be stronger, but 44 percent indicating it will not be in a good position.

In terms of current conditions, there were no significant differences between demographic groups about the state of the economy. People's beliefs in the economy a year from now are a bit more mixed. Those with the least education and the oldest respondents are most optimistic about the economy. A plurality of Republicans think the economy will be improved, but a plurality of Democrats and unaffiliated respondents are less optimistic.

"Our survey was in the field as President Trump implemented the nearly universal tariffs and the stock market dropped significantly," said David McLennan. "It is hard for people to be optimistic about the economy's future when they are worried about the price of goods and their retirement funds. The lack of optimism about the economy's future is problematic for President Trump's approval ratings and people's satisfaction with how things are going more generally."

Personal Financial Situation

Our respondents' perceptions of their personal financial situations mirror that of their perceptions of the economy. Only 1-in-4 respondents feel that their financial situation is excellent or very good with the rest indicating real concerns about their finances. In thinking about their future financial situation, almost two-thirds of the respondents think their finances will be in excellent or good shape in a year. A majority of respondents in every demographic group felt their current financial situation was fair or poor. Similarly, members of every demographic group felt that their personal financial situation would be better next year.

The key finding is that almost half of the respondents (45%) think that what happens in Washington, D.C., has a great deal of impact on their personal financial situation with another 40 percent indicating that decisions in the nation's capital have some impact. Relatively few think that federal policy decisions don't impact their personal finances.

"There is a disconnect between people's views that their financial situation will be better next year, and their pessimism about the economy," said David McLennan. "People acknowledge the importance of policy decisions in Washington on their personal financial situations, but have questions about how policy choices made there are going to make the economy stronger."

Trump Administration Policy Ideas

Deportation of Immigrants

Of the policy issues that the Trump administration has emphasized since the inauguration, deporting immigrants has the highest approval. Sixty percent of North Carolina respondents consider the efforts to deport migrants to be effective or very effective. A plurality of respondents–35 percent–would like to see the efforts increased, while a slightly lower percentage–32 percent–would like to see fewer migrants deported. One issue of concern expressed by our respondents was that of ensuring migrants received due process protections in the deportation process. A majority–58 percent–stated that those being considered for deportation deserve the same rights as American citizens, including use of warrants, access to legal representation, etc., while 29 percent do not believe that those rights are important.

The immigration issue illustrates the partisan divide most dramatically. Ninety percent of Republican respondents think the Trump policy and execution of deportations is effective, while just over one-third of Democratic respondents (34.8%) feel the same way. Almost half of the unaffiliated respondents (46.1%) believe these deportations are effective. Other groups with strong support for the Trump immigration actions include Hispanics (71%) and those with less than a high school education (75.2%).

On the related questions of whether deportations should be increased or decreased and whether immigrants deserve due process protections, a sharp partisan divide exists. While over half of Democratic respondents (57.2%) and a plurality of unaffiliated respondents (46.2%) want to see deportations decrease, 57.2 percent of Republican respondents want to see the rate of deportations increase. Likewise, on the issue of due process protections, majorities of Democratic respondents (79.3%) and unaffiliated respondents (61%) believe immigrants deserve due process protections, while just 37.3 percent of Republicans feel the same.

David McLennan states: "President Trump ran on the immigration issue in three presidential elections and deporting undocumented immigrants continues to strongly connect him with his Republican base. It is troubling to see that Republicans want deportations to increase seemingly without ensuring basic legal protections outlined in the Constitution."

Tariffs

Compared to immigration, Trump's actions on tariffs are very unpopular. Just over one-third (37%) of the respondents thought the tariffs were effective in improving the U.S. economy, with a majority (53%) having real doubts that the tariffs will have a positive effect on the economy. In a similar vein, twice as many respondents think that tariffs will hurt their personal finances (47%), rather than help their finances (23%). Almost one-in-three respondents (29%) aren't sure.

Partisan differences strongly affect people's views on the impact of tariffs on the economy. Almost two-thirds of Republican respondents (65.4%) feel tariffs will benefit the economy, while just 16.6 percent of Democratic respondents and 30.8% of unaffiliated respondents feel that tariffs are good for the economy. On the question of how tariffs will affect an individual's personal finances, almost 40 percent of Republican respondents feel that tariffs will positively affect their personal finances, while just 12 percent of Democratic respondents and 23.1% of unaffiliated respondents feel that way. There is also a large educational gap in terms of how people feel tariffs will affect them personally. A plurality of those with less than a high school diploma feel that tariffs will have a positive effect on their finances, while just 20.1 percent of those with a college degree and just 17.6% of those with a graduate degree feel this way.

"Although this is an unpopular policy for most North Carolinians and many feel that tariffs will hurt the U.S. economy and their personal finances, Republicans have a more 'wait-and-see' attitude about the impact of tariffs," McLennan said. "They are much more willing to give President Trump the benefit of the doubt even as the stock market plunges."

Cuts in Government Agencies/Personnel (DOGE)

The efforts of Elon Musk and the Department of Government Efficiency (DOGE) have produced tens of thousands of job cuts in federal agencies and the closing of some departments. A large majority of North Carolinians (67%) are concerned that these changes will affect government services, while 30 percent have little or no concern about the government's ability to provide services that people use.

The only demographic group with a majority of respondents indicating little or no concern with the federal cuts on government services is Republicans. Among this group, 53.6 percent expressed little or no concerns with the efforts of DOGE, while 42.3% of Republican respondents expressed a great deal or some concern. On the other hand, 90.2% of Democratic respondents had concerns with these government cuts.

"Americans may think that the government is too large or that there is waste in government spending, but the efforts of Elon Musk and DOGE are very unpopular in North Carolina. Even many of President Trump's loyal supporters are concerned that these cuts will affect services and payments they use," said David McLennan.

N.C. Policy Issues

Cell Phones in Public Schools

The topic of banning cell phones in public schools has deep (68% approve) and broad (almost every demographic group) support. The only group without a majority of its respondents supporting this legislation is the youngest age group (18-28) with just over a third of its respondents (37.4%) supporting such legislation. In terms of partisan support, over three-quarters of Republican respondents (76.1%) support this bill, while 57.6

percent of Democratic respondents and 59.6 percent of unaffiliated respondents support this action.

"This bill has almost universal support and reflects the perception that these devices are so distracting and that students' test scores are not where people think they should be," said David McLennan.

Limiting the Use of Some Public Restrooms to the Sex Assigned at Birth

In 2016, North Carolina passed HB2, a bill that restricted the use of public restrooms to the sex assigned at birth for a person. This law was unpopular and led to this provision of the law being rescinded. A similar bill in 2025 has much more support, with 57 percent of respondents supporting the limitation of some public restrooms to people's assigned sex. Slightly less than one-third (32%) oppose such a law. In a related provision–making the sex on a birth certificate unable to be changed–56 percent of the respondents supported such a requirement, with 34 percent being opposed.

In terms of restricting people's use of bathrooms, there was a large partisan divide, with 84.3 percent of Republican respondents supporting this bill, but only 36.9 percent of Democratic respondents and 30.8 percent of unaffiliated respondents. Among Democrats, a plurality of respondents did not support the legislation at all. Almost every other demographic group had a majority of its respondents supporting this legislation. The only group that was almost evenly divided was the youngest respondents (18-28 years old) in which 46.8 percent supported the bill and 44.2 percent opposed it.

On the topic of restricting birth certificates, a similar partisan divide between Democratic and Republican respondents exists, with 33.3 percent of Democratic respondents supporting the bill and 81.1 percent of Republicans. A plurality of unaffiliated respondents (46.4%) support the legislation. In addition to less than half of the youngest respondents supporting the bill, less than half of the Black and Hispanic/Latino respondents support the bill.

"In less than a decade, the issue of restricting transgender rights has become popular among North Carolinians," said David McLennan. "This clearly reflects the concerted efforts of national Republicans, including President Trump, to demonize this group."

Allowing Permitless Handgun Carry and Lowering the Age for Purchasing Handguns

Legislation to allow people to carry a concealed handgun without receiving a permit from a county sheriff has mixed support in the state. Forty-seven percent of respondents support such a law, while 48 percent oppose this effort. There is a partisan gap in responses, with just over a third of Democratic respondents supporting the bill (36.8), while 55 percent of Republicans support the bill.

On a related provision about lowering the age for purchasing a handgun from 21 to 18, a large majority of North Carolinians—71%—oppose such legislation with only 25 percent supporting this. A small majority of Republican respondents (55%) support such

legislation, but it is interesting to note that the age group most affected by such legislation has a majority of its respondents opposing lowering the age to purchase a handgun.

"As with most gun legislation," said David McLennan, "there are partisan differences. However, North Carolinians, as a whole, do not support additional loosening of gun laws. For many, a person wishing to get a handgun should get a permit from the county sheriff and those under 21 should be restricted from owning a handgun."

Allowing the State Auditor to Have More Authority to Cut State Agencies and Personnel (DAVE Act)

With DOGE investigating perceived waste and fraud in federal government programs, Republicans in the North Carolina General Assembly have proposed legislation empowering the State Auditor, David Boliek, to propose cuts in programs and changes in staff levels in state government agencies (DAVE Act). When asked if North Carolina state government agencies were efficient with little waste or fraud or were inefficient with a great deal of waste and fraud, a plurality of respondents—42%—supported the idea that NC offices and agencies were inefficient and had waste and fraud, while 27% thought the agencies operated efficiently. It is worth noting that almost one-third of the respondents indicated that they did not know. There were no significant differences between the demographic groups, including partisan groups.

Despite a larger percentage of respondents having the perception that the North Carolina government was inefficient and had large amounts of waste and fraud, a plurality of respondents—46%—opposed giving the State Auditor more power to cut programs and personnel in the agencies. Thirty-eight percent of the respondents support such a law. As with the perception of waste and fraud in state government, the opposition to giving more power to the auditor was across the board. It is worth noting that even a plurality of Republicans—the party of the State Auditor—oppose giving him more power to cut state agencies and personnel.

"The efforts by Republicans in the General Assembly to mimic DOGE in North Carolina is not being met by much support," said David McLennan. "Although some North Carolinians believe that the state government is wasteful in its spending of taxpayer dollars, many in the state are skeptical about giving one person or one office the power to make unilateral decisions."

Approval of Political Leaders

President Donald Trump

President Trump's approval rating among North Carolina voters has dropped significantly in the last two months since the last Meredith Poll was conducted. He is currently 15 percentage points underwater (41% Approve; 56% Disapprove). In fact, his approval rating is about 4% lower than the average of his first term in office among North Carolina voters.

Among demographic groups, there are large gaps. Only eight percent of Democratic respondents think Trump is doing a good job, while over 80 percent of Republican respondents feel the same. Among unaffiliated respondents, just over 23 percent of this group approves of his work as president. The gender gap has also grown. While just over half of all males (51.7%) approve of Trump as president, just over one-third of women approve (34.3%). Trump's strongest approval numbers continue among whites, those who live in rural areas of the state, and those with less education.

David McLennan states: "Trump is clearly being hurt by the economic turmoil in the country. As he has implemented his unpopular tariffs and government cuts, this has affected his approval numbers, even among some Republicans. He ran on the strength of his economic message and now he is being held to account for damage to the economy."

Vice President JD Vance

JD Vance's approval is similar to that of Donald Trump-40 percent. His disapproval is somewhat less than Trump's at 50 percent, but far more people don't know enough (11 percent) of his work as vice president to offer an opinion about it. Similar to President Trump, Vance has high approval ratings from Republicans (78.1%), and low approval among Democrats (9.1%) and unaffiliated respondents (23.1%).

"Vice President Vance's approval is tied to that of the president," said David McLennan. "He has demonstrated loyalty to Trump and his agenda, so as the approval of the Trump agenda goes, so does that of JD Vance."

Governor Josh Stein

North Carolina Governor Josh Stein continues to have a good start to his administration in terms of public approval. At almost the 100-day mark, Stein has strong approval ratings–56% approve, and just one-in-four respondents (25%) had no opinion of Stein's work as governor.

Among demographic groups, Stein has strong support, even among Republican voters (53% approve), as well as minority voters and in rural, suburban, and urban parts of the state. In an interesting situation, a higher percentage of unaffiliated voters expressed that they don't know about Stein's work as governor than they approve or disapprove of it.

"Governor Stein has had a good start to his term as governor," said David McLennan, "He appears to be working with Republican leadership in the General Assembly on some key issues. However, as the more controversial culture issues advance–like DEI elimination or permitless carry for handguns, he may butt heads with the leadership. This may affect his approval among Republicans."

Methodological Information

Mode: Online

Population: N.C. Registered Voters 18+

Dates in the field: April 2-8, 2025

Sample Size: 759

Credibility Interval: +/- 3.5%

Weighting Variables (NC): Gender, Education, Location (Urban, Rural, and Suburban counties). Political Party, and Race and Ethnicity.

Procedures: The Meredith Poll used an online sample provided by Qualtrics. Participants were recruited into the sample by Qualtrics and received small amounts of compensation in exchange for their opinions. The survey was not an open link posted on social media, but rather was by direct invitation to a very large national pool of people who agree to take online surveys. More information about the Qualtrics panels and quality tests are available here. Quotas on demographic variables such as gender, race, etc. were applied prior to online survey commencement.

Online interviews were included in the final dataset if respondents spent a minimum length of time on the interview and particular sections, and if a respondent progressed through the entire survey. Respondents were recruited to the survey with a generic description about the fall elections.

We used registered voters for our sample.

Credibility Interval

Unlike a traditional random-digit-dial telephone survey, online surveys do not have a traditional margin of error. Non-probability quota samples like these do not adhere to assumptions of random selection. To account for uncertainty inherent in any sample-based research design, we provide a credibility interval. More information about this technique can be found here. The credibility interval was calculated by inflating traditional confidence intervals by a design effect calculated using the squared sum of weights. For this North Carolina sample, this means: (1.0 * 2.5= 3.5). We round these values up for presentation of results. As with all surveys, Total survey error often exceeds sampling error.

Weighting Information

Weights were generated in Qualtrics using a technique known as iterative proportional fitting, also known as raking. The weight variable was calculated based on the variables in the table below.

The demographic information was obtained through self-report--respondents answered closed-ended questions.

Model—we used estimates of the North Carolina population by the US Census Bureau and voter registration totals as of 2/8/2025 provided by the North Carolina Board of Elections.
